In a plenary session, participants openly share perspectives on a specific topic by answering a list of questions that will unveil ideas, tips and solutions.

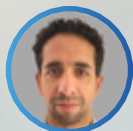

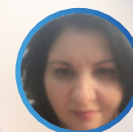
